

Social Network Policy

The State College Borough Water Authority generates this policy in reference to our digital presence on social media sites. This policy is intended to assure the Authority's and community's safety by governing, monitoring and posting comments based on strict fact that 1) comments don't come into violation of Authority Policies & Procedures, 2) comments don't violate official government views, and/or 3) comments don't jeopardize the nation's or Authority's security in any way or form.

We are open to comments/questions that relate to Authority directed topic of conversation. We review comments according to our policy below and bare the right to not post comments we feel violate the policy criteria listed below. Comments reflect the view of the writer, which doesn't necessarily reflect official views of the Authority or the state/federal governments.

If comments are unapproved, they will not be posted, meaning they do not meet the comment policy guidelines. For questions in regards to why your post has not been approved, call (814)238-6766.

The Authority will not approve or publish links of any sort. The Authority will review content prior to publishing and will not publish comments, audio/video, or photos that pertain to any of the following criteria...

- contents containing offensive, indecent, or profane language;
- threats or slanderous statements;
- remarks directed at race, sex, sexual orientation, national origin, ethnicity, age, religion, or disability;
- promotes or endorses places, services or products;
- contains sexual or pornographic content;
- photos demonstrating/supporting inappropriate behaviors, images, or compromising any of the listed criteria;
- comments that are repetitive;
- comments requesting changes or corrections on previous comments;
- contents towards misrepresentation of any one, place and/or thing;
- contents supporting/opposing political views or campaigns;
- opinions and/or statements that could lead to potential and unnecessary panic;
- contents requesting information that could make the Authority vulnerable;
- contents containing personal information (such as: e-mail addresses, phone numbers, addresses, etc.);
- contents that violate laws in any manner

*** When threatening, harassing, or violent comments are received; or fraudulent impersonation of any person or entity, an incident report will be filed and documented with the local police department.**

***Viewers who repeatedly or intentionally abuse this policy will be restricted from commenting via the Authority's social media network.**

We kindly ask posts to be respectful and non-offensive...keep posts meaningful and non-malicious. When in disagreement, we ask that you please keep it appropriate and polite towards all viewers.
